CANCELLATION POLICY

A 25% cancellation policy of the gross rate applies on holiday reservations cancelled *more than* 60 days prior to the scheduled arrival date. A 50% cancellation policy of the gross rate applies on holiday reservations cancelled *within* 60 days prior to the scheduled arrival date. A 100% cancellation policy of the net rate applies on holiday reservations cancelled *30 days or less prior* to the scheduled arrival date. For all other time periods, a credit will be applied towards a future trip completed within one calendar year from the date of cancellation, for a cancellation made greater than 14 days prior to arrival and will be equal to the amount of all deposits submitted up until the date of cancellation. For cancellations within 14 days of arrival, a 100% cancellation policy of the gross rate applies.

In the event of a Force Majeure, such as inclement weather or any unforeseen event which as a result the properties are uninhabitable and prevents the Supplier from providing the appropriate offering, all funds received from the Client will be reimbursed. If an unforeseen event occurs during any Client stay and the Properties are deemed uninhabitable, a refund will be given for the unused portion of the rental.
